The Board shall have power to accept contributions in money or property either by way of addition to the trust funds generally or for any one or more of the specified objects of the trust in so far as they are not inconsistent with any of the provisions of this trust and in either case such contributions shall be dealt with either as capital or as income according to the directions of the donors but subject to the condition that in the opinion of the trustees it is conducive to the beneficial administration of the Trust.

20. (a) The Chairman shall preside over all the meetings of the trustees and in his absence the trustees may elect any of their body to preside over the meetings.

(b) the meetings of the trustees may be convened by the Chairman or under his directions by any other trustees.

(c) Any two trustees may require meeting of the Trustees to be convened and there upon the
